

### INTRODUCTION

The rapid development of globalization processes led to the growth of interdependence and interconnectedness of the world, and new challenges are quickly becoming universal in nature and forming real threats to international security and stability. Globalization is becoming an increasingly influential "architect" of the new order at all levels of international relations and has a contradictory effect on the evolution of relations between states. On the one hand, globalization stimulates the accelerated development of productive forces, scientific and technological progress, the increase of intellectual potential and the improvement of democratic multilateral mechanisms of management of the international system, and therefore contributes to the reliable solution of regional security problems. On the other hand, the spontaneous development of globalization processes exacerbates a number of existing problems of international political, socio-economic, and environmental security and creates new risks and challenges. As a result of differences in financial and economic potentials, interaction between countries is becoming more and more asymmetrical. A small group of highly developed states play the role of leading actors of globalization, and the weakest members of the world community suffer much greater losses from the negative consequences of globalization compared to countries that are protected by their own financial and economic power. The relevance of the problem and the dynamics of modern international economic relations require a constant response to all changes in the global economy, an in-depth and careful study of their causes and consequences in the current time regime.

The purpose of the educational discipline is to form the students' understanding of the conditions and factors of formation, mechanisms and tools of the functioning of the global economy, awareness of their own and collective intellectual mission for making adaptive, rational, creative management decisions.

The tasks of the academic discipline are:

formation of professional competences in relation to knowledge of prerequisites, factors, regularities and modern trends in the formation of the global economy; processes of global corporatization of business; forms and models of regional economic integration; regularities of institutionalization of economic development; global priorities of scientific-technological, innovative-intellectual and civilizational development;

formation of the ability to analyze and forecast the nature of subject interaction in the global economy; sectoral-industry and regional-country structure of the global economy; modern functioning mechanisms of commodity, financial, service and labor markets; directions of global modification of market competitive mechanisms;

development of skills to identify factors and mechanisms of formation of global corporate leadership; cross-cultural corporate interaction, interactive interpersonal communication, personal social responsibility; planning, development and implementation of effective solutions for the production of high-quality products;

globalization; modern techniques for identifying key global business problems and justifying ways to solve them; methods of effective communications of micro-, macro- and global interaction; methods and tools of innovative technological development of Ukraine in the context of defined geo-economic priorities.

The object of study of the discipline is an economic system characterized by the emergence of interregional networks, global systems of economic interaction and exchange, global entities that form a new world economic order - the global economy.

The subject of the study of the discipline is market relations between subjects of international business, determined by the laws, trends and specifics of the functioning of the global economic system.

Interrelationship of key concepts of globalization: globality – globalization – globalism – globalists.

## **1.2.** Types, forms of manifestation, prerequisites and consequences of modern globalization.

Structuring of the globalization process. The main types of processes of global integration: economic, political, cultural, informational. Forms of manifestation of globalization. Internal contradictions of the process of globalization. The genesis of global integration. Prerequisites of globalization. Positive and negative consequences of modern globalization. Contradictions of globalization. State-political platforms for the implementation of modern globalism. Methodology, methods and tools for researching globalization processes.

#### **1.3.** Leading concepts and ideological theories of globalism.

Global studies as a science, stages of its development. Theoretical approaches to determining the chronological limits of globalization. Three waves of globalization. Cyclical-wave nature of the long-term process of the development of globalization. Evolution of the concepts and theoretical base of globalism. The main trends of the world stock markets. Financial instruments of the world market of portfolio investment in the world. International stock indices. Peculiarities of the development of the global loan capital market. World credit market.

#### **Topic 7. Global business**

## 7.1. Transnational and global corporations in the system of the global economy.

The essence of global business and its organizational forms (TNC, MNC, global corporations, metacorporations, etc.). Creation of international corporations with the aim of simultaneously entering the global market. Transnational corporations (TNCs): membership criteria, key indicators for analysis, characteristic features. The role of multinational corporations (MNCs) and international corporate unions in the system of international economic relations. Features of the modern stage of development of international corporations. Metacorporations as characteristic subjects of the global economy and their influence on the development of the modern global economy.

#### 7.2. Theoretical concepts of TNC activity as global corporations.

## **8.3.** Factors of global competitiveness and technological leadership of national economies.

The main performers / customers and sources of R&D financing in the countries of the world. The main forms of stimulation of small innovative enterprises in developed countries. High technology zones: essence and classification. Territorial structure of technology parks of the world. Models of technological development of the global economy. Models of technoparks: American, European, Japanese, Chinese. Innovation parks and business incubators in Ukraine. Venture business in the system of global economic development.

### **Topic 9. Human resources of the global economy**

### 9.1. Demographic aspect (dimension) of the global economy.

### ASSESSMENT FORMS AND METHODS

Simon Kuznets Kharkiv National University of Economics uses a cumulative (100-point) rating system.

**Current control** is carried out during lecture, practical, laboratory and seminar classes and has the purpose of checking the level of preparedness of the student of higher education for the performance of specific work and is evaluated by the sum of points scored: for disciplines with a form of semester credit control: the maximum amount is 100 points; the minimum amount is 60 points.

**The final control** includes the semester control and certification of the student of higher education.

**Semester control** is carried out in the form of semester differentiated credit or credit.

**The final grade by academic discipline** is determined for disciplines with the form of semester control of credits - the summation of all points received during the current control. During the teaching of the academic discipline, the following control measures are used: current control: individual educational and research tasks (20 points), current control work (40 points), colloquium (20 points), essay (20 points).
